The Committee discussed the upcoming en banc between the CPUC and the California Energy Commission, and in response to various issues raised about community choice prior to the en banc, Vice Chair Sheila Kuehl and Monterey Bay Community Power Chair Bruce McPherson co-authored an op-ed.

5. Discussed June 22, 2018 Board Retreat Preparation

Staff updated the Committee on the planned schedule for the June 22 Board Retreat including the three breakout sessions. The itinerary will begin with introductions and consideration of the Fiscal Year 2018-2019 Budget followed by the immediate start of the Retreat, which will include three breakout sessions. Chair Mahmud will lead the session regarding finance, Vice Chair Kuehl will facilitate the rates session, and Vice Chair Linda Parks will lead the session concerning local programs. Each of the invited speakers from the northern California CCAs will participate in a different breakout session to help inform the discussion.

SUMMARY

Staff will present the attached draft August 16 Board Agenda for review by the Executive Committee and will provide verbal updates on topics to be discussed with the Board. Additional details are provided below on Board Agenda Items 9 and 10, which staff is seeking specific feedback on from the Executive Committee.

BOARD AGENDA ITEM 9 – 2019 Rate Options

As CPA prepares to expand service in 2019, member agencies who have not yet chosen a default rate will need to do so to enable 2019 rates to be set and procurement decisions to be made. Beginning on August 20, jurisdictions will have until the end of October to make this selection. During this 10-week window, member agencies that previously selected a default will also be given an opportunity to revisit their default rate tier, and agencies that previously selected a tier only for non-residential customers will be able to select a default for all customers.

CPA is currently offering three rate tiers: 36% renewables, 50% renewables and 100% renewables. This basic tier structure will remain the same, but given that default choices must be made by the end of October before rates are set for 2019, member agencies should be aware of some caveats that apply to the available rate options.

Two main factors drive uncertainty around CPA's 2019 rates:

- SCE's 2019 rates remain unpredictable until its November 8 rate forecast (ERRA) filing
- 2. CPA is still in the process of procuring energy for 2019, leaving some uncertainty around costs

By the November 15 Board meeting, SCE will have submitted its final ERRA filing and CPA will have locked in much of its 2019 energy costs. With this added certainty, CPA can set residential rates in November ahead of the February residential roll-out. Commercial and industrial rates will be set in January or February ahead of the May roll-out for those customers.

| Rate Option | Cost Relative to SCE Rates |

| 36% Renewables | 1%-2% discount to SCE overall bill |
| 50% Renewables | Option A: Matches SCE rates with 45%-55% renewable content |

| | In jurisdictions that choose the 100% renewables rate as their default, CARE customers will be offered 100% renewable content at a cost equal to their rate with SCE by increasing the regular 100% renewables rate in those jurisdictions by an additional 0.25% |

The rate options and pre-November related considerations are shown in the table below.

Each of the above rate options contains a range of outcomes to reflect the current uncertainty. For the 36% renewables base rate, CPA is targeting a discount to the overall

SCE bill of 1.5%, but the rate discount could be higher or lower depending on SCE rates and CPA costs.

Similarly, CPA is targeting an 8% premium to SCE's overall bill for the 100% renewables rate, but this could be higher or lower depending on the same factors. Another aspect of the 100% renewables rate is the approach to qualified low-income customers who are on the Domestic CARE rate. After several discussions with member agencies who have chosen, or are considering choosing, 100% renewables as their default rate staff developed an option whereby CARE customers will be offered 100% renewables at a rate that matches SCE's base rate (approximately 34% renewables). This avoids automatically increasing costs for CPA's most vulnerable customers. The incremental cost of renewables for the CARE customers is spread amongst the other 100% renewable rate customers in those jurisdictions resulting in an increase of less than 0.25% to their rates.

The 50% renewables rate presents two options to consider. Currently, CPA is targeting a rate equal to SCE's rates for customers choosing the 50% renewables tier. If CPA's financial forecasts improve, it may be possible to either lower rates or increase the renewable content offered to customers. In choosing how to respond to improved finances, a balance between growing reserves and providing enhanced customer value will need to be considered.

Alternatively, if SCE's rates decrease more than expected or energy costs increase materially, CPA could reduce the renewable content from 50% to some lower level to ensure parity with SCE. In this case, the approach will need to balance competitiveness with SCE rates and to achieve renewable energy content as close as possible to the 50% target.

Final decisions on how to handle the 50% renewables option will need to be made at the November 15 Board meeting where rates will be set.

BOARD AGENDA ITEM 10 – Contract Amendment with The Energy Coalition

CPA entered into an agreement in March 2018 with The Energy Coalition to provide consultant services for communications, outreach, and marketing. The Energy Coalition has completed a number of deliverables critical to CPA's phase 1 and 2 enrollment, and also established a foundation for CPA's brand and overall communications strategy moving forward. To continue these efforts and to ensure continuity in preparation of the legally required materials for phase 3 and 4 enrollment, as well as launch CPA's new website and provide support to CPA's new Director of Marketing and Account Services, CPA staff will recommend on August 16 that the Board consider approving a contract amendment to extend the contract period to June 30, 2019 and approve a new \$210,000 scope of work and budget for The Energy Coalition to provide these services. As a framework for this discussion, staff will present a draft Communications & Marketing Plan (to be provided to the Executive Committee under separate cover), prepared by The Energy Coalition, which summarizes CPA's overall communications and branding strategy and outlines a workplan for the next nine months.
