Introduction and Key Information

About Our Rates

Clean Power Alliance's 2019 residential rates are established to meet standard bill comparison targets approved by our Board of Directors (1-2% cost savings for Lean Power, 0-1% savings for Clean Power, and 7-9% cost premium for 100% Green Power). These overall bill savings or premium—depending on which rate option the customer chooses—are in comparison to Southern California Edison's (SCE's) current base rates. Southern California Edison's proposal for a double digit increase to 2019 generation rates and associated fees charged to both their own and Clean Power Alliance customers to make up for a 2018 budget shortfall of over \$800 million dollars has been approved by the CPUC. This SCE rate and fee increase will go into effect in April 2019, with additional rate changes likely to go into effect in June 2019. When these rate changes occur, Clean Power Alliance will adjust our rates as needed to ensure our Board-approved savings/premiums do not change. Any future changes to Clean Power Alliance rates will be adopted at public meetings of our Board of Directors.

The rates shown in this document are for electric generation/supply only. Please visit SCE.com for delivery rates and schedules.

Rate Period Definitions

Seasons

- **Summer:** season shall commence at 12:00 a.m. on June 1 and continue until 12:00 a.m. on October 1 of each year.
- **Winter:** season shall commence at 12:00 a.m. on October 1 of each year and continue until 12:00 a.m. on June 1 of the following year.

Holidays

Applicable holidays for rate time periods are as follows: New Year's Day (January 1), Presidents' Day (third Monday in February), Memorial Day (last Monday in May), Independence Day (July 4), Labor Day (first Monday in September), Veterans Day (November 11), Thanksgiving Day (fourth Thursday in November), and Christmas Day (December 25).

When any holiday listed above falls on Sunday, the following Monday will be recognized as a holiday. No change will be made for holidays falling on Saturday.

100% Green Power Default Jurisdiction Rate

The rate for customers in Clean Power Alliance jurisdictions that selected **100% Green Power** as their default includes a small additional premium.¹ This additional premium provides funding to allow qualified customers in those jurisdictions that participate in financial assistance programs to receive **100% Green Power** at the same rates as they would have paid to Southern California Edison (SCE), including the discount provided by the financial assistance program. These programs are California Alternate Rates for Energy (CARE), Family Electric Rate Assistance (FERA), and Medical Baseline Allowance. Clean Power Alliance is committed to giving every customer the opportunity to be a champion for clean energy, as well as ensuring our customers have choices when it comes to their energy needs. At any time, customers can choose to move to our **Clean Power** option, which provides 50% renewable energy content at cost-competitive rates, or our **Lean Power** option, which provides 36% renewable energy content and offers a rate savings compared to SCE base rates. ¹ This additional premium translates to an approximate 0.6% bill increase. Jurisdictions that selected 100% Green Power default for 2019 are Culver City, Ojai, Oxnard, Rolling Hills Estates, Thousand Oaks, Santa Monica, South Pasadena, Unincorporated Ventura County, Ventura, and West Hollywood.
