ABOUT CLEAN POWER ALLIANCE

Clean Power Alliance (CPA) is the largest community choice electricity provider in California, serving approximately 1 million customers in Los Angeles and Ventura counties.

As a public entity, CPA's shareholders are our customers. Our operations are funded exclusively by customer payments for electricity, and net revenues are returned to our customers through stable, competitive rates and investment in local programs.

POWER SOURCES

CPA procures renewable energy from a variety of solar, wind, small hydroelectric, geothermal and other qualified renewable energy sources in California and on the western grid.

CPA evaluates renewable energy projects based on value, project location, development risk, environmental stewardship, workforce development, and benefits to local and disadvantaged communities. Among the long-term contracts CPA has signed since launching in 2018 are the Voyager wind project in Tehachapi and the 100 MW Luna battery storage project in Los Angeles County, one of the largest of its kind in the State of California.

CPA's board of directors sets competitively priced generation rates for our customers. Our rate structures match SCE's, including Time of Use (TOU) periods.

You can switch between rate products or opt out at any time. SCE continues to deliver electricity to your business and to set delivery rates for all customers as regulated by the California Public Utilities Commission.

Solar power and net energy metering

Clean Power Alliance's Net Energy Metering (NEM) program allows customers with rooftop solar or other eligible generating systems to receive bill credits for generating more electricity than they use each month. Customers who generate more than they consume over a year will be eligible for net surplus compensation

at a rate 10% higher than SCE's net surplus compensation rate.

ABOUT COMMUNITY CHOICE

CPA is a Community Choice Aggregation (CCA) utility. In 2002, the State of California passed legislation authorizing local governments to form CCAs to provide their communities with reliable, locally controlled electricity generation. Each of the 32 member cities and counties that make up Clean Power Alliance voted to join CPA, making CPA the default electricity provider for customers in their jurisdictions and giving customers for the first time, a choice of electricity providers and products.

There are currently 20 CCAs active in the state representing over 170 cities and counties, and more are in the process of launching. CCAs are expected to supply a majority of California's electricity over the next decade.
