Introduction

About Our Rates

Clean Power Alliance's rates are established by its Board of Directors. Any changes to Clean Power Alliance rates will be adopted at duly noticed public meetings of the Board of Directors.

The rates shown in this document are for electric generation/supply only. Please visit SCE.com for delivery rates and schedules.

100% Green Power for CARE, FERA, and Medical Baseline Customers in Default Jurisdictions

Some Clean Power Alliance jurisdictions have selected **100% Green Power** as their default CPA rate product. ¹ Customers in these jurisdictions that participate in California Alternate Rates for Energy (CARE) receive **100% renewable power** at a reduced cost.

Clean Power Alliance is committed to giving every customer the opportunity to be a champion for clean energy, as well as ensuring our customers have choices when it comes to their energy needs. At any time, any 100% Green customer can choose to move to our **Clean Power** option, which provides 50% clean energy content at cost-competitive rates, or our **Lean Power** option, which provides 40% clean energy content and offers a rate savings compared to SCE base rates. ¹Jurisdictions that have selected 100% Green Power as their default rate product are Agoura Hills, Calabasas, Culver City, Malibu, Manhattan Beach, Ojai, Oxnard, Rolling Hills Estates, Thousand Oaks, Santa Monica, Sierra Madre, South Pasadena, unincorporated Ventura County, Ventura, and West Hollywood. Effective October 1, 2022, Beverly Hills, Claremont, Camarillo, Hawthorne, and Redondo Beach have selected 100% Green Power as the default for all customers in their jurisdictions, and unincorporated Los Angeles County has selected 100% Green Power as the default for residential customers in its jurisdiction.



Rate Definitions

Seasons

For all rate schedules, seasons are defined as follows:

- Summer: season shall commence at 12:00 a.m. on June 1 and continue until 12:00 a.m. on October 1 of each
- Winter: season shall commence at 12:00 a.m. on October 1 of each year and continue until 12:00 a.m. on June 1 of the following year.

Holidays

Applicable holidays for rate time periods are as follows: New Year's Day (January 1), Presidents' Day (third Monday in February), Memorial Day (last Monday in May), Independence Day (July 4), Labor Day (first Monday in September), Veterans Day (November 11), Thanksgiving Day (fourth Thursday in November), and Christmas Day (December 25).

When any holiday listed above falls on Sunday, the following Monday will be recognized as a holiday. No change will be made for holidays falling on Saturday.
